## **Credit Suisse Life & Pensions Indonesia to change its name to Winterthur Life Indonesia, effective April 3, 2006**

Jakarta, January 16, 2006— **PT. Credit Suisse Life & Pensions Indonesia will be renamed PT. Asuransi Winterthur Life Indonesia, as of April 3, 2006, subject to Ministry of Justice approval.**

In order to further enhance its profile and to foster a consistent global market presence, the Winterthur Group has decided to re-introduce the Winterthur brand to its life insurance entities in Indonesia, replacing the Credit Suisse Life & Pensions brand that has been in use since May 2002.

The shareholding structures and the management of the company will not be affected in any way. Moreover, the name change will not result in any modification to the existing contracts of Credit Suisse Life & Pensions Indonesia clients. All stakeholders will be informed of the rebranding in due course.
